UNITED WAY OF GENESEE COUNTY NAMED PRIMARY BENEFICIARY FOR 2021 THE ALLY CHALLENGE PRESENTED BY MCLAREN

Birdies for Charity presented by Ally program returns for fourth annual tournament

The Ally Challenge presented by McLaren's philanthropic mission strengthened by new Tickets FORE Charity initiative

GRAND BLANC, Mich. – Tournament officials announced today that the primary beneficiary of net proceeds for the fourth-annual The Ally Challenge presented by McLaren will be the United Way of Genesee County (UWGC). The 2021 tournament will mark the third consecutive year that UWGC has been included as a primary beneficiary of The Ally Challenge.

"Choosing the United Way of Genesee County again allows the proceeds to be deployed across the region to a wide variety of organizations that do so much for area residents," said Andrea Brimmer, chief marketing and public relations officer at Ally. "Last year we met the challenge of the pandemic, but with fans back in the gallery this year, you'll see us really raise the bar to live up to the tournament's amazing legacy of giving back nearly \$3.2 million to local charities since 2018."

UWGC has operated in the community for over 97 years providing support addressing educational outcomes, health access, financial stability and the basic needs of its residents; the UWGC leverages donations from more than 200 workplace campaigns and individual investors to support over 150 programs. Last year dollars raised impacted over 100,000 lives representing every zip code of Genesee County.

The tournament's investment will help support over 18 programs in Genesee County, impacting more than 5,000 individuals through the three priority areas: Financial Literacy, Housing and Employment.

"The United Way is honored to once again be the charity partner of The Ally Challenge presented by McLaren," said James Gaskin, UWGC CEO. "We take these dollars and share them with 18 programs, ran by various nonprofits, throughout Genesee County impacting thousands of residents. When you visit the tournament this year not only are you seeing great golf, but you are also helping so many residents in need."

The Ally Challenge presented by McLaren has established a legacy of giving in southeastern Michigan, including raising nearly \$3.2 million in support of local charities in the greater Flint area and beyond in its first three years. The tournament will continue to positively impact the community in Genesee County and beyond in 2021 through its support of UWGC, as well as the return of Birdies for Charity presented by Ally and the addition of the tournament's newest charity initiative, Tickets FORE Charity.

Birdies for Charity presented by Ally is a grassroots charity platform, now in its fourth year, that serves as an extension of The Ally Challenge presented by McLaren's mission to positively impact non-profit organizations in the greater Flint area. This successful program has included nearly 60 participating Michigan 501(c)(3) organizations and raised more than \$1 million since it began in 2018.

Birdies for Charity gives qualified Michigan 501(c)(3) charities and schools the opportunity to raise funds based on the number of birdies made by PGA TOUR Champions players during competitive rounds at The Ally Challenge. Each participating charity will solicit pledges per birdie, or flat donations, to their organization through the Birdies for Charity program. Charities will receive 100% of collected donations, as well as a guaranteed bonus match of 10% on the first \$300,000 of donations and 5% thereafter.

All qualified non-profit organizations that register for Birdies for Charity presented by Ally are eligible to participate in the tournament's newest charitable initiative, Tickets FORE Charity. This new program gives charities an opportunity to earn extra dollars for their cause based on attendance during the final round of The Ally Challenge.

Each time a ticket, purchased with a charity's special promo code, is scanned at a tournament admissions gate on Sunday, August 2, The Ally Challenge presented by McLaren will donate \$10 to that designated charity. In addition, a \$5,000 bonus pool will be split amongst the top three charities receiving the most scanned tickets.

"Combined with the return of Birdies for Charity presented by Ally and the new Tickets FORE Charity initiative, The Ally Challenge is poised to continue building on the overwhelming success the tournament achieved in its first three years providing a positive charitable impact for the community in southeastern Michigan and beyond."

The fourth playing of The Ally Challenge presented by McLaren will be contested the week of August 23-29, 2021 at Warwick Hills Golf and Country Club.

The Ally Challenge will be one of the premier Regular Season events on PGA TOUR Champions in 2021, which will give way to the Charles Schwab Cup Playoffs – a season-ending, three tournament series used to determine the TOUR's season-long champion. Due to the circumstances related to the COVID-19 pandemic, PGA TOUR Champions has combined its tournaments in 2020 and 2021 to form one season, and the next Charles Schwab Cup champion will be crowned in November 2021 at the Charles Schwab Cup Championship.

All three rounds of The Ally Challenge presented by McLaren will be broadcast on Golf Channel.
